KNOW ALL MEN BY THESE PRESENTS: THAT I, Glenn Jordan, do hereby appoint Gloria K. Bowden, Karen V. Danielson, Anita Jane Kamenz and Sharon P. Nixon, each acting individually, my true and lawful attorneys for me and in my name for the purpose of:
