KNOW ALL MEN BY THESE PRESENTS: THAT I, Brent Hastie, hereby appoint Gloria K. Bowden, Jared M. Brandman, Karen V. Danielson and Anita Jane Kamenz, each acting individually, my true and lawful attorneys for me and in my name for the purpose of:
