The 2019 Annual Meeting of Shareowners of The Coca-Cola Company will be held on April 24, 2019 at World of Coca-Cola, 121 Baker Street, NW, Atlanta, Georgia 30313 at 8:30 a.m. Local Time.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends that you vote **FOR** the following proposals:

1. To elect the 13 Director nominees identified in the Company's Proxy Statement to serve until the 2020 Annual Meeting of Shareowners.
2. To hold an advisory vote to approve executive compensation.
3. To ratify the appointment of Ernst & Young LLP as Independent Auditors of the Company to serve for the 2019 fiscal year.

The Board of Directors recommends that you vote **AGAINST** the following proposals:

4. To vote on a shareowner proposal regarding an independent Board Chair.
5. To vote on a shareowner proposal on sugar and public health.

Note: To transact such other business as may properly come before the meeting and at any adjournments or postponements of the meeting.
